CODE ENFORCEMENT  
VIOLATIONS

Do not place junk or trash curbside on any day other than the day before collection day. Currently collection is on Tuesday, which means trash or junk can be placed on the curb on Monday. This includes yard waste as well.

Do not park cars or other vehicles in grassy areas period. All vehicles must be parked on durable surfaces such as concrete, asphalt, or brick. Gravel may be permitted with approval.

Do not allow clutter, rubbish, debris to accumulate outside the home in either the front or the back.

Do not add to any property without applying for and being granted proper permits.

Do not drive/park any unlicensed vehicle on any city street.

VIOLATIONS

**You may not park your vehicle facing against the flow of traffic on any roadway in the city.**

You may not park your vehicle on any city roadway for more than 24 hours.

Pets must be on a leash at all times when not within the confines of your property.

Owners must clean up after pets.

Owners will be cited for pets that are deemed a consistent nuisance i.e. - barking.

**Operation of any repair garage on a residentially zoned property is prohibited.**

**Heavy trucks (5000 lbs or above) are prohibited from parking in residentially zoned areas.**

VIOLATIONS

Inoperable vehicles are not permitted. A vehicle is considered inoperable when it has flat tires, does not start, is missing wheels, has broken windows or other missing parts required for driving.

It is unlawful to park any vehicle within 10 feet of any fire hydrant; nor may ingress or egress to fire hydrants be blocked.

You may not post personal business related signs on a residential property other than for Real Estate sales purposes.

**DO NOT ALLOW YOUR PETS to roam freely throughout the neighborhood. Pet owners are responsible for any damage your pet does to property or person.**

VIOLATIONS

The violations listed within this pamphlet are all citable offenses that if convicted, could result in prosecution, penalties, fines, court costs, attorney fees, and even the possibility of imprisonment.

Homeowners should be aware that if a Code Enforcement Official is asked to review your property, ALL offenses will be addressed and will require immediate action.

**Fines assessed by Louisville Metro Code Enforcement can range from**  
**\$100 per offense/per day**

**\$1000 per offense/per day**

**City of Lynnview Ordinance No. 555**  
**Property Maintenance Code Violation Penalty - Series 2018-2019**

Passed June 11th, 2019

Establishes the first-time penalty amount for any property maintenance code violation to \$500. Subsequent violations for the same offense will be increased at the rate of \$500 each time there is a subsequent offense.

Violations can be sited **daily**.
